Dear Administrator Brooks-LaSure:

The Association of California Life and Health Insurance Companies appreciates the opportunity to comment on the Centers for Medicare and Medicaid Services' (CMS) request for information specifically on Medicare Advantage.

We represent more than 40 health and life insurance companies at the forefront of helping Californians meet their financial and retirement needs. Our members provide more than \$2.5 trillion in insurance coverage across the state.

By 2060, the number of Americans over age 65 is projected to nearly double.¹ Health care coverage through Medicare and Medicare Advantage remains critically important for seniors. We believe that choice in Medicare is important with seniors having multiple forms of coverage to choose from including traditional Medicare, Medigap, and Medicare Advantage.

There are currently more than three million California seniors relying on Medicare Advantage for high-quality, patient-centered, affordable coverage.² Through Medicare Advantage plans, California seniors have access to supplemental benefits including vision, dental, and hearing. Additionally, 95% of Medicare Advantage plans offer telehealth benefits.³
